4 The Parliament of Australia enacts:

5 1 Short title

6 This Act is the *Electoral Legislation Amendment (Party*
7 *Registration Integrity) Act 2021.*

8 2 Commencement

3 ***Commonwealth Electoral Act 1918***

4 **1 Subsection 123(1) (subparagraph (a)(ii) of the definition of**

5 ***eligible political party*)**

6 Omit “500”, substitute “1,500”.

7 **2 After section 123**

8 Insert:

9 **123A Determining whether a non-Parliamentary party has at least**

10 **1,500 members**

11 (1) In determining for the purposes of this Part whether a political
12 party that is not a Parliamentary party has at least 1,500 members,
13 the same member may not be relied on by more than one party.

14 (2) If an individual is a member of more than one political party that is
15 not a Parliamentary party, then, for the purposes of subsection (1):
16 (a) only the party nominated by the member may rely on the
17 individual as a member; and
18 (b) no party may rely on the individual as a member if, after the
19 Electoral Commission has given the individual at least 30
20 days to do so, the individual has not nominated a party.

21 **3 Paragraph 126(2)(ca)**

22 Omit “include a list of the names of the 500”, substitute “for an eligible
23 political party that is not a Parliamentary party—include a list of the
24 names of the 1,500”.

25 **4 Subsection 126(2A)**

26 Repeal the subsection.

27 **5 Before subsection 129(1)**

28 Insert:

1 *Names not to be registered*

2 **6 Paragraph 129(1)(b)**

3 After “obscene”, insert “, frivolous or vexatious”.

4 **7 At the end of section 129**

5 Add:

6 *Names to be registered only with consent*

7 (3) The Electoral Commission must refuse an application for the
8 registration of a political party if:

9 (a) either of the following apply:

10 (i) the applicant party’s name contains a word that is in the
11 name, or the abbreviation of the name, of a registered
12 political party;

13 (ii) the proposed abbreviation of the applicant party’s name
14 contains a word that is in the name, or abbreviation of
15 the name, of a registered political party; and

16 (b) the application is not accompanied by the written consent, to
17 the use by the applicant party of the word in its name or
18 abbreviation, of:

19 (i) if there is only one registered political party to which
20 paragraph (a) applies—the registered political party’s
21 registered officer; or

22 (ii) otherwise—the registered officer of the first such
23 political party to be registered.

24 (4) For the purposes of subparagraph (3)(b)(ii), if the registered
25 political parties to which paragraph (3)(a) applies are a State
26 branch, and the federal branch, of a federal party that were
27 registered on the same day, the federal branch is taken to be the
28 first of those political parties to be registered.

29 (5) Subsection (3) of this section, and subsections 129A(2) and
30 134A(1), do not apply to:

31 (a) a function word; or

32 (b) a collective noun for people; or

8 Section 129A

Before “The”, insert “(1)”.

9 At the end of section 129A

Add:

13 (2) The Electoral Commission must refuse to enter in the Register a
14 logo of a political party (the *applicant*), set out in an application to
15 register the applicant, if:
16 (a) the applicant's logo contains a word that is in the name, or
17 the abbreviation of the name, of a registered political party;
18 and
19 (b) the application is not accompanied by the written consent, to
20 the use by the applicant of the word in its logo for the
21 purposes of registration under this Part, of:
22 (i) if there is only one registered political party to which
23 paragraph (a) applies—the registered political party's
24 registered officer; or
25 (ii) otherwise—the registered officer of the first such
26 political party to be registered.

Note: Subsection (2) has effect subject to subsections 129(5) and (6).

(3) For the purposes of subparagraph (2)(b)(ii), if the registered political parties to which paragraph (2)(a) applies are a State branch, and the federal branch, of a federal party that were registered on the same day, the federal branch is taken to be the first of those political parties to be registered.

(iii) the name or logo of the second party contains a word that is in the name, or abbreviation of the name, of the parent party; and

12 Paragraph 134A(1)(aa) (second occurring)

Repeal the paragraph.

13 At the end of subsection 134A(1)

Note: Subparagraph (1)(a)(iii) has effect subject to subsections 129(5) and (6).

14 After subsection 134A(1)

Insert:

(1A) If, in relation to a second party mentioned in subsection (1), there is more than one registered political party that meets both of the following conditions (each such party is an *earlier registered party*):

- (a) the party was registered before the second party;
- (b) the party has in its name, or the abbreviation of its name, a word contained in the name or logo of the second party;

then only the registered officer of the first of the earlier registered parties to be registered with that word in its name or abbreviation may make an objection under paragraph (1)(b) to the continued use of the name or logo by the second party.

(1B) For the purposes of subsection (1A), if the earlier registered parties are a State branch, and the federal branch, of a federal party that were registered on the same day, the federal branch is taken to be the first of the earlier registered parties to be registered with the word in its name or abbreviation.

4 Omit “candidate; or”, substitute “candidate.”.

5 **17 Paragraph 136(1)(b)**

6 Repeal the paragraph.

7 **18 Paragraph 137(1)(b)**

8 Omit “has ceased to have at least 500”, substitute “does not have at least
9 1,500”.

10 **19 At the end of subsection 137(1)**

11 Add:

12 Note: In determining whether a party has at least 1,500 members, the same
13 member may not be relied on by more than one party (see
14 section 123A).

15 **20 Application of amendments**

16 *Membership requirements*

17 (1) The following amendments of the *Commonwealth Electoral Act 1918*
18 (the *Act*) made by this Schedule apply, after this item commences, in
19 relation to a political party other than a registered political party:

20 (a) the amendment of the definition of *eligible political party* in
21 subsection 123(1);
22 (b) the amendment of subsection 126(2);
23 (c) section 123A so far as it relates to those amendments.

24 (2) Subitem (1) has effect in relation to a political party other than a
25 registered political party:

26 (a) whether or not the party has applied for registration under
27 Part XI of the Act; and
28 (b) whether any such application was made before or after this
29 item commences.

Schedule 1 Amendments

1 (3) The following amendments of the Act made by this Schedule apply
2 from the start of the day after the end of the period of 3 months
3 beginning on the day this Act receives the Royal Assent:
4 (a) the amendments of section 137;
5 (b) section 123A so far as it relates to those amendments.

6 *Party names*

7 (4) The amendments of sections 129 and 129A of the Act made by this
8 Schedule apply in relation to an application for the registration of a
9 political party made after this item commences.

10 (5) The amendments of section 134A of the Act made by this Schedule
11 apply, from the day this item commences, in relation to all political
12 parties, regardless of their date of registration.
